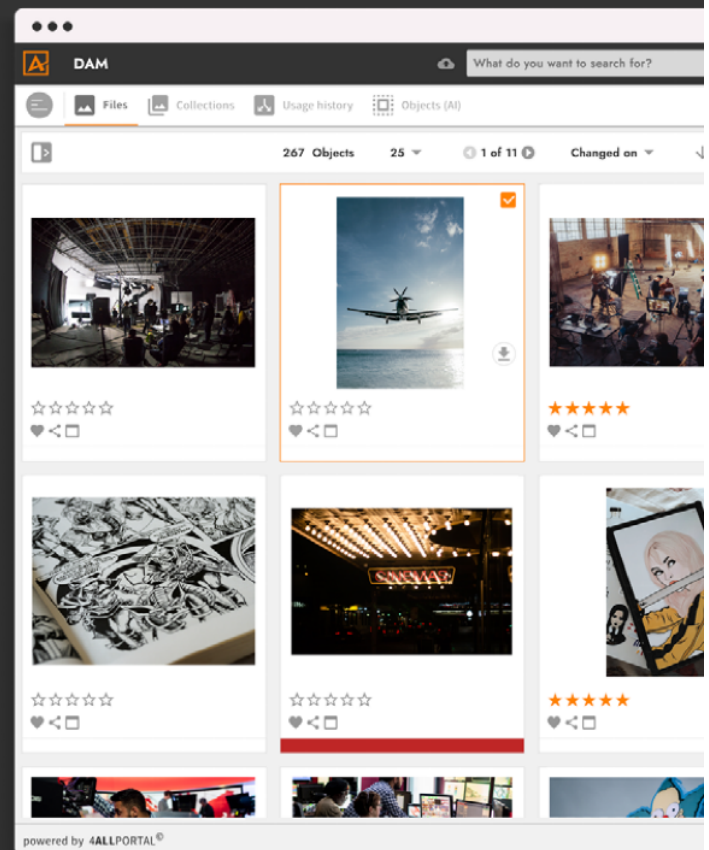

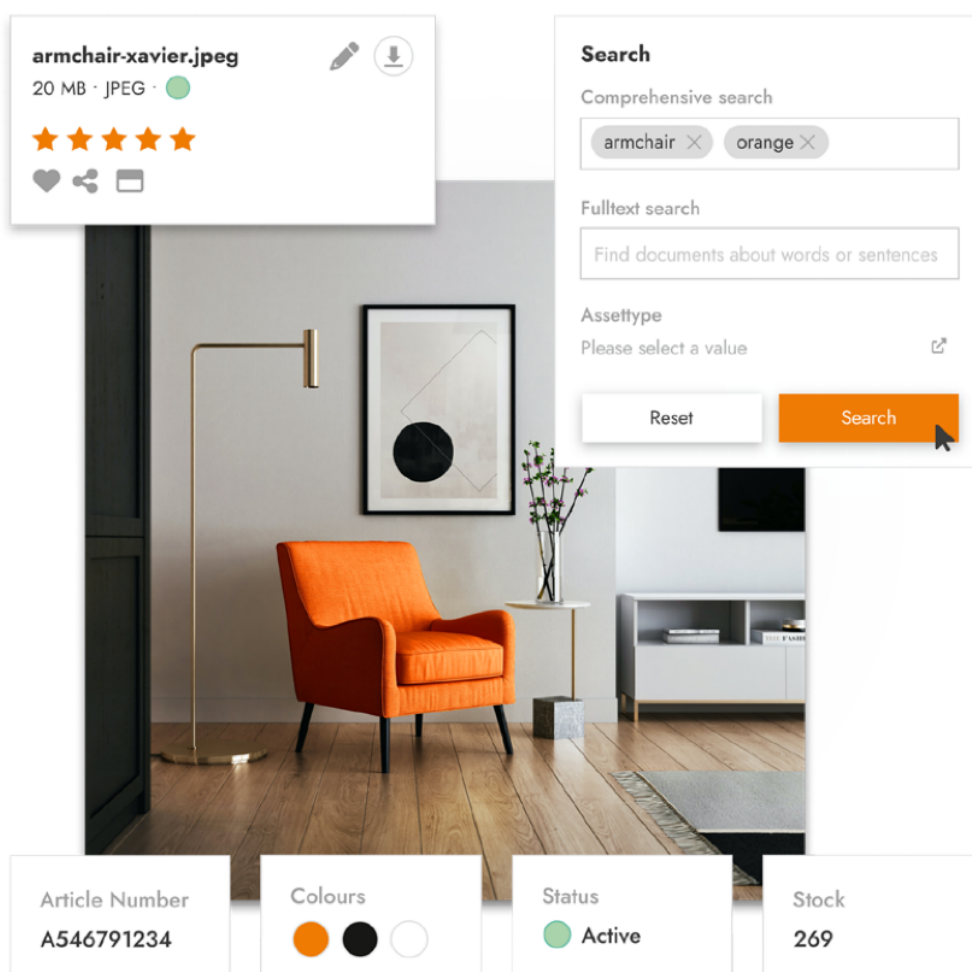

Current management Your assets:

- Files are spread all over the place: on different computers, a central server, network drives, cloud services or hard drives.
- Files are not always named consistently, following a certain format
- Folder structures are the primary method of organizing and managing files.
- You often look for certain files, but don't know where they are stored or the exact file name.
- There are multiple "final" versions of assets or duplicates of files due to saving in multiple formats.
- Assets are mostly shared via email or external filesharing and cloud services.
- It is not always obvious whether a file may be used or if a source must be referenced.

Current workflows in the company:

- There are certain employees who are responsible for editing and sharing files within the team.
- Files for the website/shop are edited and uploaded manually.
- Images are used to the best of each person's knowledge, without exact clarity about the usage rights.
- You often look for certain files, but don't know where they are stored or the exact file name.
- Sharing large files with internal or external persons is often more difficult than expected and requires third-party software.
- Field sales staff require quick access to digital files.
- Many employees lack licenses for certain software, meaning they cannot preview files or access data.

Who should be involved in selecting a DAM solution?



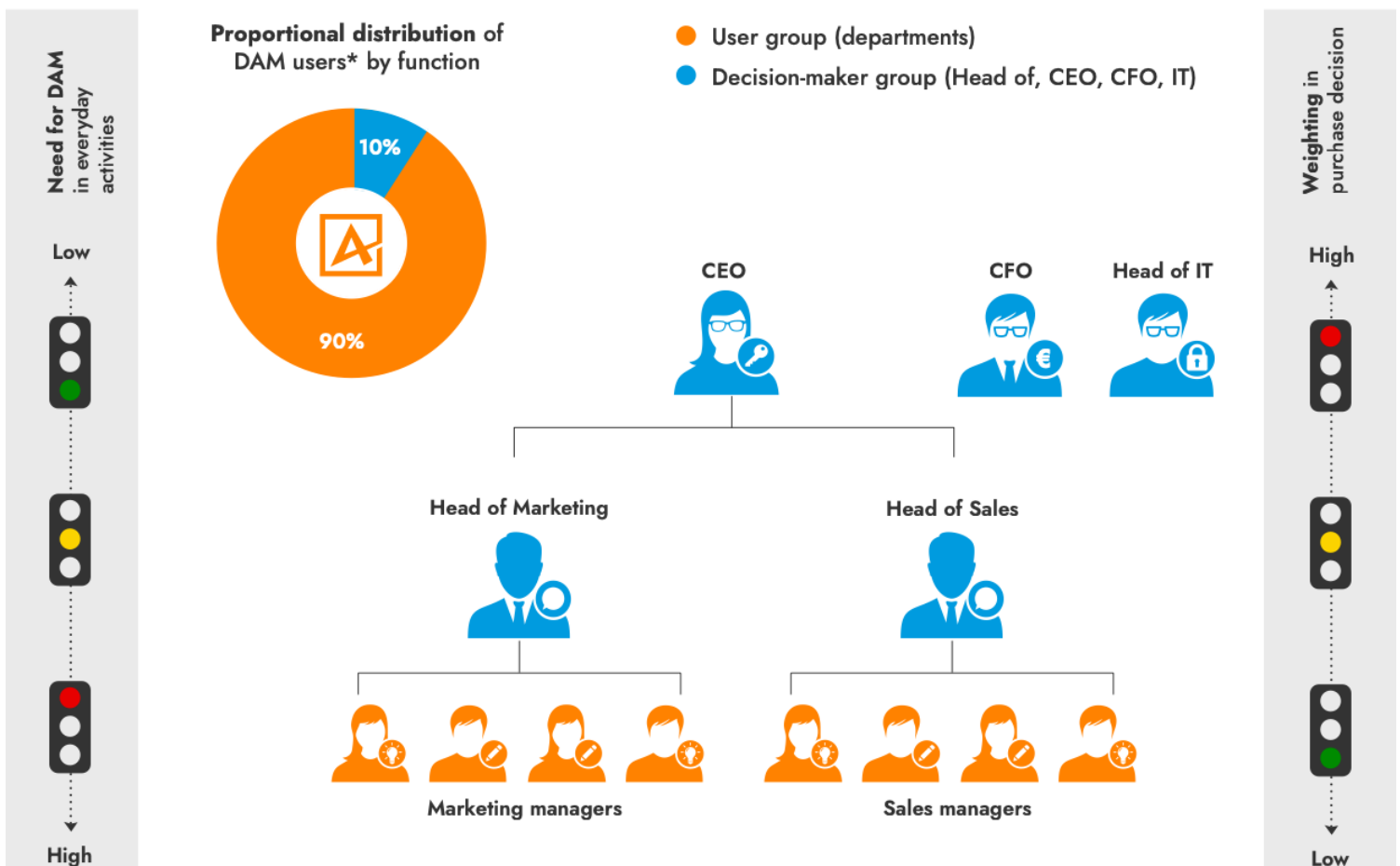
For a smooth transition to DAM, it is essential that you determine precisely which groups of people should be involved, and how each group will benefit from DAM.

Why is a rough division into user and decision-maker groups advisable?

The greatest need for a DAM solution can usually be found in the marketing, product management and sales departments. Employees of these departments make up around 90% of all DAM users; managers, only around 10%.

No matter which part of your company has the greatest need for DAM: the respective department, IT and CFO/purchasing should be involved early on in the process, to understand how it can benefit them.

Individual taxonomy & custom metadata structure

One basic requirement of a DAM system is a flexible metadata structure, allowing you to form an individual taxonomy for the management of your data. This information is used for tagging, i.e. adding keywords to assets, and searching using your individual filters.

- ✓ Organization according to your preferences
- ✓ Expandable/minimizable views

Integrated workflows to optimize your processes

Especially in creative work processes, it is often necessary to ask others for their input – for example, in the course of correcting or approving your work. When these interactions simultaneously take place via email, Teams, telephone or conversations by the coffee machine, it can quickly get complicated.

- ✓ Faster completion & approval
- ✓ Fewer correction cycles

Scalable management of access rights & roles

The larger your user group, the more important it is to have a scalable system with customizable access rights. Only then can you prevent unauthorized access to sensitive data and the unlicensed use of (expired) images and stock photos.

Manage usage rights via metadata

What would good rights management be without integrated workflows? Nothing! That's why it's vital that the usage rights for your assets can be flexibly controlled for individual user groups (in other words, who is allowed to view, edit, share, download assets).

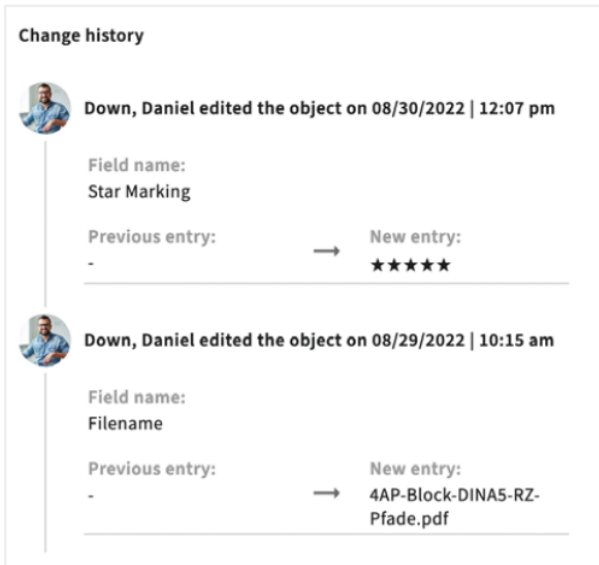

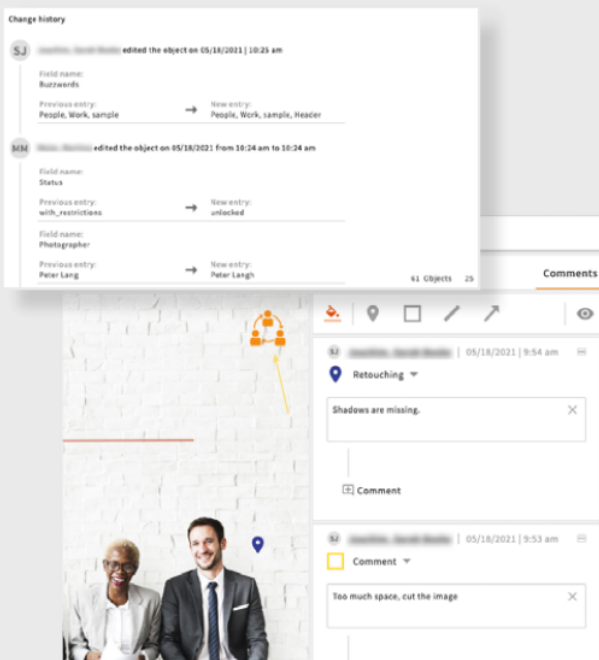

Make changes to your assets transparent

A change history is like a log book for your data. It helps you to identify who has worked on an asset and which metadata have been removed, modified or added, etc. This function is especially useful during correction cycles.

Manage approval workflows via a central module

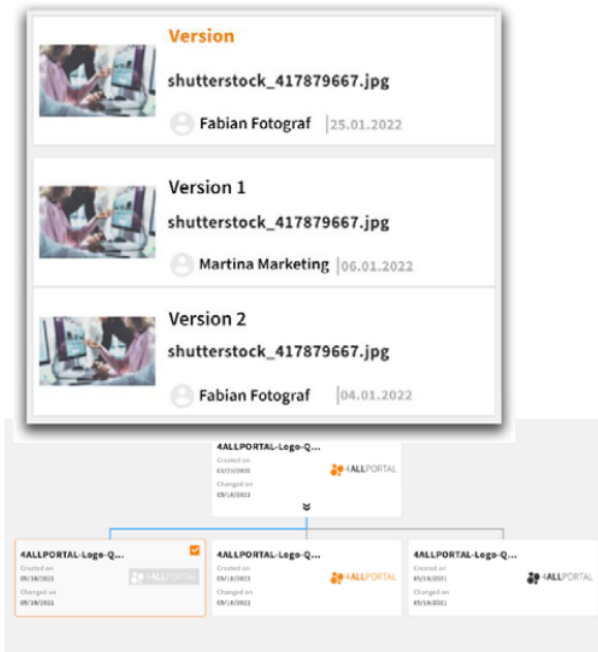
For most of us, it is not out of the ordinary for an approval process to involve several correction cycles. Nevertheless, you should make sure that your new DAM has a dedicated function for the streamlining of approval processes.

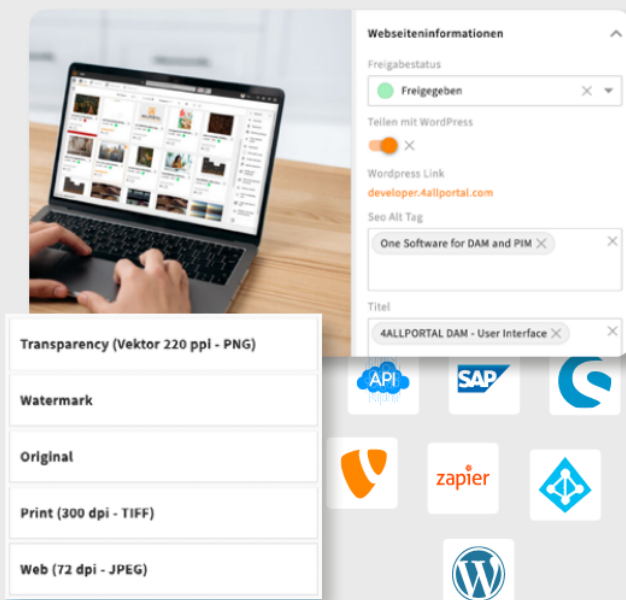

Organize all the versions of your assets in one central location

Instead of complicated naming conventions, such as *filename_final-version_v2.jpg* and countless similar files, only the most recent version is visible to selected user groups. Old versions are hidden and are only visible to admins and creators.

As a central hub, your new DAM should integrate seamlessly in your existing tech stack of software tools and provide all the essential platforms and channels with content, whether it's for social media, paid ads, SEO or content for your website and shop.

Reports and analyses of asset use

Which assets were used most frequently and which target channels were data exported to? All this information should be centrally available to admins, project managers and department managers. That way, you always know exactly what's going on with your data.

Flexible hosting: cloud and on-premise

When selecting a DAM solution, you should make sure that it supports both hosting by the customer ("on-premise") and cloud hosting by the DAM provider. Likewise, you should check its server location and GDPR conformity.
